Finance Manager

The Finance Manager serves as part of the senior management team that reports directly to the General Manager. This position provides long-term direction for the financial operations of ALP, manages the board of directors' fiscal policies, and assists in the development of new policies. Major responsibilities include providing regular reports to the five-member board, and overseeing and managing the Billing and Customer Service, Procurement, Facilities and HR functions of ALP.

The ideal candidate should have five years of electric utility experience and at least three years of supervisory experience. A bachelor's degree in business administration, with an emphasis in accounting and finance, is required. An advanced degree and/or professional certification (e.g., MBA, CPA, CIA, CMA) is desirable. The Finance Manager must have a thorough knowledge of both Generally Accepted Accounting Principles (GAAP) and a working knowledge of government accounting and reporting as established by the Governmental Accounting Standards Board (GASB), and experience with budgeting and forecasting, internal controls, understanding of local, state and federal laws and regulations impacting the electric utility industry, and experience with financial accounting software. However, extensive accounting and finance experience in a related field may substitute for electric utility employment.
