AN ORDINANCE AMENDING THE 2024 FEE SCHEDULE FOR VARIOUS LICENSES AND PERMITS FOR THE CITY OF ALEXANDRIA

The City Council of the City of Alexandria, Minnesota, does ORDAIN:

The fee will be 65% for all other buildings. There will be a fixed fee of \$50 for plan review for detached garages and \$25 for decks.

Installation, replacement, or moving of all domestic water heaters, domestic hot water storage tanks, range boilers, and all domestic water heating appliances pertaining to plumbing: \$24.00/each

All repair or remodeling jobs, changing or replacements of each individual plumbing fixtures:

\$7.50/each

Installation of roof drains and roof overflow drains when piping to such drains are run inside of buildings and wasted into a storm drain system including natural storm drain run-off areas:

In commercial, industrial, multi-family residential, one and two family dwellings and institutional structures, the permit fee shall be based on the valuation of the entire plumbing installation, which is to be declared on the permit applications.
