ORDINANCE NO. 558 2ND SERIES

AN ORDINANCE AMENDING CITY CODE CHAPTER 10 IN ORDER TO CLARIFY STANDARDS REGARDING PLACEMENT AND USE OF RECREATIONAL VEHICLES AND **EQUIPMENT**

The City Council of the City of Alexandria does **ORDAIN**:

SECTION I. That Section 10.02, Subdivision 44 (Campground) of the Alexandria City Code is hereby amended by deleting the existing language.

SECTION II. That Section 10.02, Subdivision 53 of the Alexandria City Code is hereby amended by deleting the existing language and replacing it with the following:

Subd. 52. Commercial Recreation. Includes all uses such as, but not limited to, bowling alleys, roller and ice skating rinks, driving ranges, and movie theaters that are privately owned and operated with the intention of earning a profit by providing entertainment for the public.

SECTION III. That Section 10.02, Subdivision 187 of the Alexandria City Code is hereby amended by deleting the existing language and adding the following language:

Subd. 188. **Recreational Vehicle.** A vehicular-type unit primarily designed as temporary living quarters for recreational, camping, or travel use, which either has its own motive power or is mounted on or drawn by another vehicle.

SECTION IV. That Section 10.02 is hereby amended by adding the following language:

Subd. 186. Recreational Camping Area. Any area, whether privately or publicly owned, used on a daily, nightly, weekly, or longer basis for the accommodation of recreational camping vehicles free of charge or for compensation.

Subd. 187. Recreational Equipment. Items that are used off the road including but not limited to boats, canoes, and snowmobiles.

SECTION V. That Section 10.03 is hereby amending by adding the following language:

Subd. 14. **Recreational Camping Areas.** This ordinance shall regulate recreational camping areas under the following requirements.

- 1. Minimum number of 20 sites.
- 2. Yearly operation to be no more than 180 days.
- 3. Secure a state license for operation of the campground.
- 4. On-site manager required.

SECTION VI. That Section 10.05, Subdivision 4(D) is hereby amended by deleting the existing language and adding the following:

D. Recreational Camping Areas

SECTION VII. That Section 10.11, Subdivision 4 is hereby amended by adding the following language:

N. Recreational Camping Areas

SECTION VIII. This Ordinance shall be in full force and effect from and after its passage and publication.
