**AN ORDINANCE ESTABLISHING A FEE SCHEDULE FOR VARIOUS LICENSES AND PERMITS
FOR THE CITY OF ALEXANDRIA**

The City Council of the City of Alexandria, Minnesota, does **ORDAIN**:

**A plan review fee will be charged for all building permits required to have a plan. The fee will be 50% of the building permit fee for 1 & 2 Family Dwellings. The fee will be 65% for all other buildings.

1. Inspections outside of normal business hours (minimum charge – two hours) \$47.00 per hour

- 2. Reinspection fees assessed \$47.00 per hour
- 3. Inspections for which no fee is specifically indicated \$47.00 per hour
(minimum charge – one hour)
- 4. Additional plan review required by changes, additions or revisions to plans \$47.00 per hour
(minimum charge – one hour)

PLUMBING PERMITS FEE SCHEDULE

Installation, replacement, or moving of all domestic water heaters, domestic hot water storage tanks, range boilers, and all domestic water heating appliances pertaining to plumbing: \$20.00/each

All repair or remodeling jobs, changing or replacements of each individual plumbing fixtures: \$7.50/each

Installation of roof drains and roof overflow drains when piping to such drains are run inside of buildings and wasted into a storm drain system including natural storm drain run-off areas: \$7.50/each

In commercial, industrial, multi-family residential, one and two family dwellings and institutional structures, the permit fee shall be based on the valuation of the entire plumbing installation, which is to be declared on the permit applications.

MECHANICAL PERMITS FEE SCHEDULE

Fee for the installation, replacement, or moving of all mechanical equipment: \$20.00/each unit

In commercial, industrial, multifamily residential, one and two family dwellings and institutional structures, the permit fee shall be based on the valuation of the entire mechanical installation, which is to be declared on the permit application.

Following is the fee schedule:

\$ 0 to 2000 = \$40.00	\$9001 to \$10000 = \$115.00
2001 to 3000 = 45.00	10001 to 11000 = 125.00
3001 to 4000 = 55.00	11001 to 12000 = 135.00
4001 to 5000 = 65.00	12001 to 13000 = 145.00

¹ The \$750.00 fee is a deposit in addition to the building permit fee. If the actual cost is less than \$750.00, the permit holder will be reimbursed the difference.
