The City Council of the City of Alexandria does ORDAIN that the Home Rule Charter of the City of Alexandria be amended as follows:

Sec. 7.09. Contracts and Purchases

Subd. 1. Bids Required When.

In cases of work to be done by contract or in the purchase of property of any kind, where the amount involved is more than the amount authorized by state statue to be expanded without securing competitive bids therefore, unless the council, by an emergency ordinance, shall otherwise provide, the city administrator shall procure bids in such manner as may be designated by the council. Contracts of this magnitude shall be let only to the lowest responsible bidder. The council, however, may reject any and all bids. This section shall not apply to contract or purchases of the Board of Public Utilities as set forth in Section 10.03, Subd. 3.
