#### CHAPTER 7 TRAFFIC AND PARKING REGULATIONS

Section 7.01 **Definitions**. The definitions of terms used in this Chapter shall be those definitions set forth in <u>Minn</u>. <u>Stat</u>. § 168.011, as amended, and <u>Minn</u>. <u>Stat</u>. § 169.011, as amended, as well as those definitions contained herein.

Subd. 2. Trailer. **"Trailer"** means any vehicle designed for carrying property or passengers on its own structure and for being drawn by a motor vehicle but does not included a trailer drawn by a trucktractor semitrailer combination or an auxiliary axle on a motor vehicle which carries a portion of the weight of the motor vehicle to which it is attached.

Section 7.07. <u>Recreational Vehicle Parking and Trailer Parking.</u> It is unlawful for any person to leave or park recreational vehicle, as defined herein, on or within the limits of any street or right of way, except where signs are erected designating the place as a campsite, for more than twenty-four (24) hours. It is unlawful for any person to leave or park any trailer, detached from its towing vehicle, on or within the limits of any street or right of way.
